# **How to Use**

Local elected officials and their communities have a critical role to play in the 2024 presidential cycle. NLC—through its bipartisan Presidential Election Task Force—will work with candidates, campaigns and the next administration to understand the needs and values of local communities. As a local leader, you can help support this effort by conducting your own on-the-ground outreach to the candidates and campaigns that visit your region.

Use this toolkit to choose the option that makes the most sense for you and customize these talking points for your community and your conversations with candidates.

Keep in mind that a conversation or meeting with a candidate does not constitute an endorsement. Instead, take this opportunity to highlight the needs of your community and so many of America's cities, towns and villages and the value intergovernmental partnership will bring to the next president.

## Tips for Effective Outreach:

- ▶ Invite candidates and their surrogates to tour local facilities such as community centers, infrastructure projects, or neighborhoods to highlight federal priorities in action and foster indepth conversations with members of your community.
- If you are unable to host a public event, **consider inviting candidates for personal meetings** to discuss federal priorities.
- ▶ Engaging with campaign surrogates and senior campaign staff is also an effective form of advocacy. Seek opportunities to have personal conversations with policy decision-makers. In many cases, senior campaign staff later become White House advisors and agency appointees.
- If you are unable to meet personally with candidates or campaigns, use the provided talking points to **draft a letter to the editor or op-ed** timed to publish in coordination with candidates' visits to your community for debates, town halls, rallies and other campaign stops. If you are interested in authoring an op-ed, our team is available to provide guidance, resources and support. Please reach out to media@nlc.org for more information.

# 2024 Presidential Election Local **Official Advocacy Talking Points**

Local elected officials and their communities have a critical role to play in the 2024 presidential cycle. We engage in the national dialogue and support the democratic process by connecting candidates to our communities and building strong intergovernmental partnerships at the local, state and federal level.

Communities across the country are ready to partner with the next president's administration to address pressing issues that impact the daily lives of people who reside in them.

# Priority #1: Ensure Local Government Has a Seat at the Federal **Decision-Making Table**

- Local government plays a vital and irreplaceable role in our nation's governance, and it is crucial that the voices and needs of cities, towns, and villages across America are represented at the federal level.
- Our nation's president must always prioritize consistent, ongoing intergovernmental engagement and strong partnerships to ensure local input in federal policy decisions.
- ▶ Appointing leaders and officials with local government experience to key Administration roles can provide valuable perspectives.
- The participation of local officials in advisory committees, roundtables, and other opportunities will help ensure agency actions incorporate a local perspective.
- A strong and direct line of communication between the National League of Cities and its members, and the White House will continue to bring value to effective local-federal collaboration.

# **Priority #2: Promote Good Governance and Direct Federal Support** to Localities

- ▶ About 76% of the approximately 19,500 incorporated places have fewer than 50,000 people, and about 63% of America's 328.2 million residents live inside these small communities. Regardless of population size, all cities must continue to be eligible for federal grant assistance at scale so that the benefits of federal programs and policies reach all of our country's communities.
- Municipal governments ensure that residents are kept safe, critical utilities are kept running, infrastructure is maintained, and that our communities are healthy, economically vibrant places to live.
- ▶ Local leaders exercise good stewardship of federal resources and are the decision-makers best positioned to ensure funding is spent effectively in each unique community. This means trusting local officials to make good decisions for our residents, removing unnecessary barriers or intermediaries to accessing funding, eliminating federal preemptions of local authorities, or preventing unfunded federal mandates.
- ▶ We must also make the federal government easier for communities of all sizes to use by simplifying program requirements and making it easier for our communities to get answers, information and technical assistance from federal agencies.

# Priority #3: Celebrate Civil Discourse and Engagement in the Democratic Process

- Most local governments are elected on a nonpartisan basis. We know that the issues we tackle every day, from potholes to public parks, are not Democratic or Republican and require nonpartisan, practical solutions. Local leaders are known for exemplifying bipartisan and nonpartisan collaboration to solve local challenges.
- Civil discourse is at the heart of our democracy and local officials lead by example in fostering constructive conversations. We celebrate the vibrant civic participation within our communities, where residents and leaders work closely together to make a difference.
- ▶ Local leaders are committed to ensuring residents have access to reliable information to help them make decisions, maintain confidence in their government, and be active participants in the democratic process.
- Our commitment to civil discourse and strong engagement reflects our dedication to work with the next president to build an inclusive and responsive federal government that works for all Americans, regardless of where they live.

# 2024 Federal Action Agenda

In addition to the above principles, we encourage the next president to focus on the issues outlined in the National League of Cities 2024 Federal Action Agenda:



## Make government work for all communities

Regardless of population size, all municipalities must continue to be eligible for federal grant assistance, at scale, so that the benefits of federal programs and policies reach all of America's communities. We support efforts to provide access and build capacity of small, mid-sized, rural, and disadvantaged communities.



# Support a local workforce pipeline

The next president should support an at-scale investment in workforce development, training and apprenticeship programs to ensure America's communities have the skilled labor to address infrastructure, clean energy and advanced manufacturing priorities.



## **Build safe and healthy communities**

As local leaders continue to serve on the front lines addressing our nation's public health and safety, having a strong federal partner in this work is essential. From mental health and substance use services to community violence, the health and safety of our cities, towns and villages requires direct and flexible funding to ensure effective strategies are implemented.



### Prevent federal overreach of communities

Federal preemption of core local authorities and unfunded mandates threaten the ability of local leaders to balance budgets, maintain key services, manage growth and ensure the safety and usability of public spaces. NLC will continue to protect local authority and avoid undue costs and burden on municipalities.



# Increase housing supply and stability

NLC urges the next president to help localities do more with their housing dollars and maintain long-term efforts through direct funding, grants, and tax-credits that accelerate development and improvements and stability programs that support residents in distress.



### Support local economic growth and opportunity

Economic development is achieved by investment in the human and physical infrastructure in a region. The next president should improve the capacity of local governments to grow and improve their economies. NLC will continue to advocate for federal investments that catalyze local economic growth.
