RE: Support for the Streamlining Federal Grants Act of 2023 (HR 5934)

Dear Chairman Comer and Ranking Member Raskin:

On behalf of the nation's local governments and charitable organizations working to advance the public good, the National League of Cities, National Council of Nonprofits, National Association of Counties and International City/County Management Association write to express our strong support for the bipartisan *Streamlining Federal Grants Act of 2023* (H.R. 5934/S. 2286), which will standardize and coordinate grant administration across the federal government to reduce complexity for communities and organizations applying for federal grants. In particular, the bill would expand the accessibility of federal grants to a wider pool of local governments and organizations in small and rural communities. We urge the House Committee on Oversight and Accountability to include H.R. 5934, the Streamlining Federal Grants Act, for markup at any future Full Committee Business Meeting before the 118th Congress adjourns.

This important, bipartisan, and bicameral legislation would improve the effectiveness and performance of federal grants and cooperative agreements, simplify the application and reporting requirements, and facilitate greater coordination among agencies responsible for delivering services to the public. Notably, the legislation also seeks to improve the services delivered to communities and organizations that historically have not directly received federal grants or cooperative agreements. Specifically, this bill would:

Provide Clarification of Notices of Funding Opportunities (NOFO). The legislation
expressly requires that agencies must "improve user experience" by mandating summaries
of notices of funding opportunities that are short (under 500 words), clear (plain language),
and accessible (identifying training and assistance opportunities). Applicants would no
longer have to sift through 70 pages of jargon to determine whether they are or are not

- eligible to apply, which is especially onerous for small and rural applicants with limited staff resources.
- Elevate Training and Assistance for Potential Applicants of Grants. A primary tenet of the legislation is to improve the delivery of services to the public, particularly services by communities and organizations that historically have not received federal grants or cooperative agreements. One way this is accomplished is by requiring agencies to include in their Agency Plans the steps necessary to ensure potential grant and cooperative agreement program applicants are provided opportunities to receive training and assistance in accessing federal grant opportunities from the agency.
- Emphasize Access to Federal Grants. The legislation orders a report that identifies why
 non-federal entities choose not to participate in federal grantmaking and offering options to
 improve access. The study must include the experiences of rural and small communities
 and community-based organizations, among others. The release of the report is timed to
 ensure that solutions can be incorporated into Agency Plans for streamlined grant-making
 procedures.

S. 2286 was introduced by Senators Gary Peters (D-MI), John Cornyn (R-TX) and James Lankford (R-OK) and reported out of Committee in July 2023. Companion legislation, H.R. 5934, was introduced by Representatives Marie Gluesenkamp Perez (D-WA) and Virginia Foxx (R-NC) in October 2023 and is awaiting a vote in the House Oversight Committee. Matching Senate action by adding this important, non-controversial bill for committee markup would signal the support necessary to advance more quickly in the future.

Collectively, our organizations represent the nation's 19,000 cities, towns and villages, 3,069 counties and 35,000 nonprofits throughout the United States. Passing the *Streamlining Grants Act* will broaden the reach of federal grants and help ensure that federal dollars are providing a long-lasting impact in the communities that need them most. The National League of Cities, National Association of Counties, International City/County Management Association and National Council of Nonprofits urge the House Oversight Committee to consider H.R. 5934 before the 118th Congress ends.
